The regular meeting of the School Board of the Oregon School District was called to order by Board President Krista Flanagan at 6:30 PM on July 22, 2024 in the OSD Innovation Center at the Oregon High School in the Village of Oregon, Dane County, Wisconsin. Ms. Garrison moved and Ms. Wright seconded a motion to amend the previous motion to increase 2024-2025 breakfast and lunch prices by 0.20. Additional discussion was held.
