MINUTES OF THE REGULAR MEETING OF THE SCHOOL BOARD OF THE OREGON SCHOOL DISTRICT HELD ON APRIL 22, 2024

The regular meeting of the School Board of the Oregon School District was called to order by Superintendent, Dr. Leslie Bergstrom at 6:35 PM on April 22, 2024 in the OSD Innovation Center at the Oregon High School in the Village of Oregon, Dane County, Wisconsin. Upon roll call, the following Board members were present: Ms. Ahna Bizjak, Dr. Caleb Bush, Ms. Heather Garrison, Dr. Mary Lokuta, Mr. Troy Pankratz, Ms. Leslie Wright and Ms. Krista Flanagan. Board member(s) absent: None. Administrators present: Dr. Leslie Bergstrom, Mr. Andy Weiland, Ms. Jina Jonen, Mr. Jon Tanner, Ms. Erika Mundinger, Dr. Candace Weidensee, Ms. Darci Jarstad Krueger, Dr. Shannon Anderson and Ms. Katie Heitz. Proof in the form of a certificate by the Oregon Observer of communications and public notice given to the public and the Oregon Observer and a certificate of posting as required by Wis. Stat. sec. 19.84 as to the holding of this meeting was presented by Dr. Bergstrom.

Dr. Lokuta moved and Mr. Pankratz seconded the motion to proceed with the meeting as posted. In a roll call vote, the following members voted yes: Dr. Lokuta, Mr. Pankratz, Ms. Bizjak, Dr. Bush, Ms. Garrison, Ms. Wright and Ms. Flanagan. Motion passed 7-0.

A. REORGANIZATION:

- 1. Board Members Oath of Office: Dr. Bergstrom announced that Mr. Pankratz and Dr. Lokuta took their oath of office prior to the Board meeting.
- 2. Election of Officers:
 - a. President: Dr. Bergstrom opened the floor for nominations for President. Ms. Garrison nominated Ms. Flanagan for President. Dr. Bergstrom asked if there were additional nominations. Mr. Pankratz moved and Dr. Lokuta seconded the motion to close the nominations for President and cast a unanimous ballot for Ms. Flanagan for President. In a roll call vote, the following members voted yes: Mr. Pankratz,Dr. Lokuta, Ms. Bizjak, Dr. Bush, Ms. Garrison and Ms. Wright. Motion passed 6-0 with Ms. Flanagan abstaining from the vote. Ms. Flanagan accepted the nomination.
 - b. Vice President: Ms. Flanagan opened the floor for nominations for Vice President. Ms. Bizjak nominated Mr. Pankratz for Vice President. Ms. Flanagan asked if there were additional nominations for Vice President. Ms. Bizjak moved and Dr. Lokuta seconded the motion to close the nominations for Vice President and cast a unanimous ballot for Mr. Pankratz for Vice President. In a roll call vote, the following members voted yes: Ms. Bizjak, Dr. Lokuta, Dr. Bush, Ms. Garrison, Mr. Pankratz, Ms. Wright and Ms. Flanagan. The motion passed 7-0. Mr. Pankratz accepted the nomination.
 - c. Treasurer: Ms. Flanagan opened the floor for nominations for Treasurer. Ms. Bizjak nominated Dr. Lokuta for Treasurer. Ms. Flanagan asked if there were additional nominations for Treasurer. Ms. Garrison moved and Mr. Pankratz seconded the motion to close the nominations and cast a

unanimous ballot for Dr. Lokuta for Treasurer. In a roll call vote, the following members voted yes: Ms. Garrison, Mr. Pankratz, Ms. Bizjak, Dr. Bush, Dr. Lokuta, Ms. Wright and Ms. Flanagan. The motion passed 7-0. Dr. Lokuta accepted the nomination.

d. Clerk: Ms. Flanagan opened the floor for nominations for Clerk. Dr. Lokuta nominated Ms. Bizjak for Clerk. Ms. Flanagan asked if there were additional nominations for Clerk. Ms. Garrison moved and Ms. Wright seconded the motion to close nominations and cast a unanimous ballot for Ms. Bizjak for Clerk. In a roll call vote, the following members voted yes: Ms. Garrison, Ms. Wright, Ms. Bizjak, Dr. Bush, Dr. Lokuta, Mr. Pankratz and Ms. Flanagan. The motion passed 7-0. Ms. Bizjak accepted the nomination.

 - Policy 323 Students Who Are Homeless and Unaccompanied Youth: Ms. Garrison moved to approve Policy 323: Students Who Are Homeless and Unaccompanied Youth as brought forward by a 3-0 vote from the Policy Committee. Discussion was held. In a roll call vote, the following members voted yes: Ms. Garrison, Dr. Bush, Dr. Lokuta, Mr. Pankratz, Ms. Wright and Ms. Flanagan. Motion passed 6-0.
 - 2. Official Designations:
 - a. Newspaper: Dr. Lokuta moved and Mr. Pankratz seconded the motion to approve the Resolution to name the Oregon Observer as the official District newspaper. Discussion was held. In a roll call vote, the following members voted yes: Dr. Lokuta, Mr. Pankratz, Dr. Bush, Ms. Garrison, Ms. Wright and Ms. Flanagan. Motion passed 6-0.
 - b. Resolution regarding Investment of District Funds: Ms. Wright moved and Dr. Bush seconded the motion to approve the Resolution regarding Investment of District Funds. Discussion was held. In a roll call vote, the following members voted yes: Ms. Wright, Dr. Bush, Ms. Garrison, Dr. Lokuta, Mr. Pankratz and Ms. Flanagan. Motion passed 6-0.
 - c. Resolution Depositories: Dr. Lokuta moved and Ms. Garrison seconded the motion to approve the Resolution regarding Depositories for District Funds. Discussion was held. In a roll call vote, the following members voted yes: Dr. Lokuta, Ms. Garrison, Dr. Bush, Mr. Pankratz, Ms. Wright and Ms. Flanagan. Motion passed 6-0.
 - 3. Appointment of Representatives:

Resolution to Support the DNR Grant for Oregon Area Splash Pad: The DNR grant is a matching grant and the Oregon-Brooklyn Optimist Club has raised approximately \$340,000 to-date plus some donated materials. Mr. Pankratz moved and Ms. Wright seconded the motion to approve the resolution to support the DNR grant for up to \$450,000 and allow the Optimists to fundraise the additional \$110,000 required match. Discussion was held.

Ms. Wright made a friendly amendment to Mr. Pankratz's motion to approve the resolution to support the DNR grant for up to \$375,000 and allow the Optimists to fundraise the additional \$35,000 required match and commit the OSD to funding the remaining amount after the fundraising is complete. Mr. Pankratz agreed to the amendment. In a roll call vote, the following members voted yes: none. The following members voted no: Mr. Pankratz, Ms. Wright, Dr. Bush, Ms. Garrison, Dr. Lokuta and Ms. Flanagan. The motion failed 0-6.

Ms. Garrison moved and Dr. Lokuta seconded the motion to approve the resolution to support the DNR grant for \$350,000 and allow the Optimists to fundraise the additional \$10,000 required match and commit the OSD to funding the remaining amount after the fundraising is complete. Discussion was held. In a roll call vote, the following members voted yes: Ms. Garrison, Dr. Lokuta, Dr. Bush, Mr. Pankratz and Ms. Wright. The following member(s) voted no: Ms. Flanagan. Motion passed 5-1.

- Approval of the Dane County New Teacher Project Shared Services Agreement: Dr. Lokuta moved and Mr. Pankratz seconded the motion to approve the 2024-2025 Shared Service Contract - Dane County New Teacher Project (66.0301). Discussion was held. In a roll call vote, the following members voted yes: Dr. Lokuta, Mr. Pankratz, Dr. Bush, Ms. Garrison, Ms. Wright and Ms. Flanagan. Motion passed 6-0.

features of FES and the educational opportunities our net zero building offers. Dr. Bergstrom then shared photos of students participating in Earth Day activities; a kindergarten engineering project; first graders learning about birds; second graders learning about bees; students learning about pollinators; using Cheez-Its to learn math and students working on bird and fish Tessellations in art class. She shared photos of recent events around the district, including the Lift Every Voice and Read event at FES; Dinner and a Book at FES; RCI's pep band performing during an all-school assembly and the 25th annual OHS Art Department Art Show. Dr. Bergstrom congratulated the 25 OHS student athletes who recently signed their Letter of Intent to play at the college level. She also shared a photo of the soccer team honoring their favorite educators of Teacher Appreciation Night at a recent game. And finally, Dr. Bergstrom congratulated the students who were named Badger Conference Top Scholars for their academic accomplishments.
